# **Neighbors You Should Know**

The story of Craig and Betty Alexander began in Charlotte, North Carolina.

Craig was born in Upper Darby, a suburb of Philadelphia. His father worked for a textile plant. He was transferred and the family moved to North Carolina when Craig was 2 or 3 years old. When Craig was in his second year of high school they moved to Charlotte.

Betty was born and raised in Charlotte. After the Alexanders moved in across the street from where Betty lived, Craig's mother had Betty over for dinner, where she first met Craig. Betty confesses that she was not particularly impressed with him. At the time, both Betty and Craig were going to boarding prep schools so they did not see much of each other. Betty remembers telling her roommate of her initial impression of Craig and the roommate has often kidded Betty about this over the years.

On the other hand, Craig states he thought Betty was attractive but since they went to separate schools, it kept any relationship from developing. That version has probably won him some points over the years.

Betty went to Queens College in Charlotte and Craig went to Davidson College in Davidson, both in North Carolina. Even though they were still attending school in different places, they started dating and married after graduation.

Craig continued on to medical school at the University of Pennsylvania and his bride got a teaching job in Haddon Heights, New Jersey, using her degree in Home Economics. She was assigned to teach nutrition. She also vividly remembers her first job trying to teach Marriage and Family Living to a class full of football players when all they wanted to hear about was the sex part.

During this time, Christian and Craig III were born. Betty remembers how small the apartments were after the children arrived. She recounts how they almost took their lives in hand just to get up at night and try to move about without falling over something.

Craig finished medical school and his internship. First joining the Public Health Service in Baltimore then to Winslow, Arizona, at a hospital on the Navajo reservation run by the Indian Health Service. He was one of three doctors giving medical attention to the people in this vast geographic area. Betty said when the women were close to the time to have their babies they would

come and camp outside the wall that surrounded both the hospital and staff living quarters.

After a year in Arizona they returned to Philadelphia where Craig did further studies in Pharmacology department and also completed a residency in anesthesia. During this time, Baine was



born on a snowy winter day after Betty packed and lugged her suitcase – just in case – on the commuter train and in the cab to the doctor's office where she actually went into labor.

The next adventure – off to Denmark where Craig studied brain blood flows in relation to strokes. The children attended Danish schools for a year and everyone enjoyed the experience.

Upon return to the States, Craig took a job at the University of Connecticut Medical School. They were building a new hospital and opening a new Department of Anesthesiology. There were problems and delays in finishing the hospital. Perhaps it was time to head west again.

Craig took an offer to go to the University of Wisconsin, where he joined the medical school as head of the Anesthesiology Department. The Alexanders stayed in Madison for about 20 years.

Betty kept herself busy with her family and volunteer work for the orchestra league, a thrift shop for the hospital, organizing a womens' auxiliary and as a docent at an art museum. She also earned a Masters degree in Social Work, which she used in the Oncology department in order to support patients who had been diagnosed with cancer.

In 1986 shortly after the death of her mother, Betty was invited to come to Door County for some crosscountry skiing on ladies' weekend by Mary Webster. The

Websters live on Glidden Drive and Betty fell in love with the area. She thought they should come up again and Craig wisely agreed to Betty's suggestion. It was not long until they bought the current house.

They used it on weekends until Craig retired when it became their full time home for a few years. They realized if they stayed here all the time they would become strangers to Adam, Alex, Beckett, Lang, Lily, Quinn, You Qi and Wyeth, their eight grandchildren, so they bought a townhouse in the Philadelphia area. Now they are close to those important things such as school plays, sports and birthdays.

They are in Philadelphia from mid fall to mid spring and here for the rest of the year if they are not traveling. They have always liked to travel; early family outings were camping trips. On the first one they went to Canyon De Chelly in Arizona and had only sleeping bags—no tent and no lanterns. When they woke up the next morning they found their children peering over the edge of a cliff into the canyon below. They had set up a bit close to the edge. Later trips were a bit less traumatic and better lit when setting up.

More recently, Betty and Craig have taken many Elderhostel trips to such places as Australia, China, Spain, France, Costa Rica and Nova Scotia. Craig says it is a great way to see new things, meet curious people and learn from some pretty good professors in the lectures that are part of the trips.

They also get to take a lot of pictures. For years, Craig has been an avid photographer. He uses a view camera and is quite into black and white photography. When they remodeled their Glidden Drive house, they added a darkroom. Lately he has gotten into digital cameras and all the new toys that go with it. Craig did not volunteer it but I noticed he is teaching a photography course this summer at the Peninsula Art School.

Betty says when spring comes she can hardly wait to return to Glidden drive. Every year it is a joy to come here. She loves the way the people generously take time for you here. She states people are extraordinary in this way and she appreciates the relaxed pace.

Craig would put the people ahead of all else as the main attraction of our place. Besides a unique set of people, Craig also relishes the overall environment which has lots of subjects for his photography.

We may all wonder as we shovel out again, if winter is not really permanent. Believe it or not spring will come and Craig and Betty will return along with our other "seasonal" friends and neighbors. It will be good to see them all.

# The Candidates Speak

For the April 6 election, County District 15 includes all of Glidden Drive. County Supervisors serve for two years.

Charles Jarman is the incumbent and is opposed by Peter Polich.

For Sevastopol Town Supervisor, two of four positions will be filled this year. Both are for a two-year period. Jo Ann Schley and Gerald Worrick are the incumbents and are opposed by John Staveness and Dan Woelfel. We asked each candidate to submit a statement in their own words and a picture.

# For County Supervisor, District 15

#### **Charles Jarman**

I am 68 years old. My wife, MaryAnn and I have been married for 48 years and have 3 children: Bill, Mark, and Ann. I was born in Sevastopol, have lived on and

operated the family farm all of my life. The farm is now operated by my son, Mark; I am retired now but sill help him as much as I can.

I served 8 years on the Sevastopol School Board, 4 years as President and 4 years as a labor negotiation representative. Some of the accomplishments achieved during those 8 years were the implementation of an all-

In regard to the "Answer Man" question about phosphorous in Shivering Sands Creek, the high level of phosphorous is not due to improper operation of the Sevastopol Sanitary District Sewage Treatment System. There are several other sources of phosphorous in the stream — primarily non-point such as field erosion, runoff from barnyard, roads and other impervious surfaces.

Regarding replacement of Supervisors in midterm, the law states that the Clerk/Treasurer has a vote equal to the other members of the Board and is required to vote in such election. At the Annual Town meeting on April 8, 2003, the Clerk/Treasurer's position was made into "an appointed position by the Town Board" by a majority vote of the electors. At the Town Board meeting December 15, 2003, a resolution was passed appointing Linda D. Wait to fill the position, effective January 1, 2004.
